**Superintendent McDowell - School/District Update:** We are in the middle of hiring season. We received a resignation from our K-4 Principal/Director of Student Services so we have posted for this position. We have hired a new Resource Teacher and currently conducting interviews for our K-4 Spanish Teacher. We are engaging in the process of hiring counseling and nursing positions as well. We hope to have all vacant positions staffed by May. We are pleased that we can increase programs next year for service learning and community engagement.

We are starting professional development K-5 in a new ELA program that we have been piloting. Band and Music program will be back with the return of Ms. Meeker. We are working with a partner from MIT to provide more application-based math opportunities. We are really excited next year to do more around bear families, assemblies, and school spirit work. This will be a big part of our work around culture and climate.

**Foundation Update:** Ian and Chad provided an update on the Foundation and requested FAC feedback and input on strategy for next year. Currently at 95% participation and projected gross around \$1.93M. Discussed the new strategy implemented and success. \$1.7M ongoing commitment to the district to sustain new programs.
